

SA Police Legacy Ambassador Nomination Application

The role of an SA Police Legacy Ambassador is to support and promote SA Police Legacy within the SAPOL family and in the wider South Australian Community. It is a prestigious position appointed by SA Police Legacy.

The responsibilities of an SA Police Legacy Ambassador include:

- being a champion SA Police Legacy in order to increase awareness across SA Police and the wider community, including Cadet Sign Up sessions;
- representing SA Police Legacy when required, including being visible on the website and/or social media (unless otherwise agreed);
- undertaking activities including volunteering at or speaking at internal events which positively reflect the principal purpose of SA Police Legacy;
- agreeing to a goal to fundraise a minimum of \$1 000 per year, via pre-approved fundraising campaigns; or by providing in-kind donations that benefit the deliverables of SA Police Legacy; and
- referring members who may require assistance or support from SA Police Legacy.

An Ambassador will typically be someone who has had previous involvement with SA Police Legacy including, but not limited to:

- As a board member (now retired/resigned);
- As a Young Legatee over the age of eighteen);
- As a volunteer who has assisted at SA Police Legacy events or with other events which raised funds for SA Police Legacy;
- As a serving or retired member, (as defined in the Constitution of SA Police Legacy Inc); and/or
- As a business partner, supporter or key stakeholder.

An SA Police Legacy Ambassador may self-nominate or may be nominated by a member, board member or staff member of SA Police Legacy. The application is approved by the Manager and the Engagement & Fundraising Lead.
