Accordingly, nominations should demonstrate a contribution of an exceptional nature and significance, beyond what would ordinarily be expected through involvement with SAPL.

Nominations for Honorary Life Membership may be submitted to the CEO of SAPL. All nominations will be presented to the Board for consideration and endorsement, with endorsed nominations submitted for ratification at the Annual General Meeting.

Honorary Life Membership is conferred and held in accordance with the SAPL Constitution.
